# WATERCRAFT STICKERS AND KEYS



## REGISTRATION

Get your boat stickers and keys starting April 1st, 2011. You can stop by the Village Hall or order them through the mail. Every watercraft must have both a state registration sticker and a Village sticker. In order to purchase a Village sticker, you must have a valid state registration on file with the Village. If you purchase a new boat, a processed application for state registration will be accepted for this year. The Village has past years' registrations on file. If you are unsure of your status, please call the Village Hall. Boat stickers will not be issued without one of these documents. Village boat launch (in Sunshine Subdivision) keys may also be purchased at the Village Hall or through the mail. To order by mail, send a check payable to the Village of Third Lake for the appropriate amount, a copy of state registration (if required), and a list of your watercraft by type and state registration numbers. For your convenience, there is an application form on our website, [www.thirdlakevillage.com](http://www.thirdlakevillage.com). Or, visit the Village Hall during office hours.

## PIERS

This year when placing your pier please remember to take into consideration the rising level of the lake and adjust the height accordingly. This will keep your pier from floating away when the water level rises. **Each Pier shall display the street address number of the property at the furthest point from the shoreline in Arabic numerals not less than 3 inches in height.**
