- 9. President Report Mayor Buckley said that the smaller machine is now at the Village for the dredging project. The rip rap will be completed first. Mayor Buckley said that the dead shrubs at Grant and Sunshine have all been removed and Avon Township will be out this week to dig up the root balls.

- 11. Engineer Report Mayor Buckley reported that he received the MFT number today for the cul-de-sac, parking lot and S. Lake Ave storm drain. He explained that he sent the drawing to LCFP so that access to the path can be confirmed.
- 12. Committee Reports
 - A. Finance Mayor Buckley stated that all the three older banking accounts are now closed. He explained that the end of fiscal year 2023 numbers shows a gain of \$34,000 even after completion of the Mariner's Cove Pond project and the addition of the garage to the Village Hall.
 - B. Lakes Mayor Buckley stated that the LCHD is creating a chain of custody for the collection of lake samples beginning in June. He said that we will try to sample on the same dates as the dissolved oxygen meter readings.
 - C. Planning/Development Mayor Buckley explained that he and Clerk Smith have reviewed the Municode draft document. Clerk Smith stated that the trustees should notify her of any additional changes soon, since the corrections to the draft are due by May 22.
 - D. Public Safety Mayor Buckley stated that he has not installed the speed bumps yet since the heavy machinery will be used at the Village Hall for the dredging project. He

- explained that he would like to evaluate the effectiveness of the speed bumps since they cause damage to the road.
- E. Public Works Mayor Buckley said that there were a few more dead trees on village property that he removed. He explained that he had discussed the dead trees on the Serbian property, however, the property manager at the church property has changed and it may take awhile for those trees to be removed.
