- 1. Chairman Morthorst called the meeting to order at 7:02 p.m.

3. Approval of Minutes May 26, 2020

- 5. Discussion
 - A. Commissioner candidate Chairman Morthorst introduced David Von Breisen as a candidate for the open position on the Lakes Committee.
 - B. Fitness Swimming Chairman Morthorst reported that there was an incident on Third Lake with a motorboat and a swimmer who was not wearing protective colors or have a spotter. Swimmer has acknowledged he should have been more careful.
 - C. Carp Fishing Hillstrom reported that he will contact the carp fishermen and find out if they will be catching carp this season. President Buckley reported that there have been complaints about carp fishermen shining bright lights shining into residents' homes on Druce Lake and he will speak with the fishermen.
 - D. No Wake Buoys Morthorst reported that all village buoys are in the lake and are 150 ft away from shore.
 - E. VLMP (Volunteer Lake Monitoring Program) Morthorst reported that he took water samples to the Lake County Health Department lab last week. Water samples will be taken from Third Lake and Druce Lake through September.

- F. Fish Survey Morthorst reported that a fish survey will be conducted on Third Lake and Druce Lake sometime between mid-September and mid-October.
- G. LCHD (Lake County Health Dept) status Morthorst reported that testing has been delayed one month due to COVID-19 and will be testing will be extended until September.
- H. Boat Registrations Deputy Clerk Smith reported that 173 boats are registered with the Village.
- I. Village Boat Launch Deputy Clerk Smith reported that residents are not required to purchase a Village Launch key.
- J. Ski Course Deputy Clerk Smith reported that there were two complaints regarding the water ski course. The skiers are starting very early in the morning and are driving the boat very close to shore. Smith reported that the complaints were made prior to the buoys being placed.

6. Open to the Floor

President Buckley reported that Lake County Sheriff has not been able to give the Village a schedule for lake patrol since there has been a reduction in the Lake County budget due to COVID-19. Buckley reported that when the lake patrol comes to Third Lake, it will be out on a short notice and probably for a two hour limit.
