

Parking, Snow Removal And **Plow Damage**



As much as we love the beauty of fresh fallen snow, the roads need to be plowed. The plow operators do their best to provide clean streets, but occasionally may hit a mailbox or scrape a section of sod near the curb. If this happens, please report the incident to the Village by submitting a photograph of the damage to * thirdlake@comcast.net. Please include your name, street * address and a contact method to facilitate follow-up action. A temporary mailbox will be provided until Spring or when a new post can be installed.

In general, a plow truck will make the first pass to open the roads and will come back at a later time to fine tune the rest, so please be patient.

Please remember to shovel your sidewalks and around fire hydrants to keep us all safe. Help the postal service by clearing in front of your mailbox as well.

Calling in a vehicle left overnight after a snowfall of one inch or more will not excuse you from receiving a violation and parking ticket. Note that there is no parking of any vehicle on the streets at any time within 12 hours after a snowfall of one inch or more according to Ordinance No. 21-03-02.

This ordinances will be enforced and will result in the issuance of a parking fine and or towed vehicle.

Basic safety tips for safe snowmobiling include:

- Never consume alcohol or drugs before or during a ride.
- Know your equipment, and make sure that equipment is in proper working order.
- Wear sensible, protective clothing designed for snowmobiling, including a full-size helmet, goggles, or face
- Avoid wearing long scarves, which may get caught in moving parts of the snowmobile.
- Know the terrain you are going to ride.
- Drowning is one cause of snowmobile fatalities; when not familiar with the body of water or thickness of the ice,
- snow conditions in the area.
- Always use the buddy system and never ride alone or unaccompanied.
- Be careful when crossing roads; come to a complete stop
- Travel at a reasonable rate of speed for visibility and

The Illinois Department of Natural Resources (IDNR) reminds snowmobile operators and riders to focus on safety



Noncompliance of this ordinance requiring the registration of all rental properties may be assessed with a fine according to Ordinance 10-06-05. The registration form is available on the village website.

Is Your COVID-19 Test Site Legit?

If you've been looking for a COVID-19 test, you probably know they are in short supply. Unfortunately, scammers love to "help" with shortages and pop up sites are everywhere. Here are some questions to ask when in doubt.

Q: Who is authorized to perform COVID-19 tests?

A: It is not required under Illinois law to be a licensed healthcare professional to perform the test. Collection sites are not regulated, but the labs that test the samples are regulated by CLIA certified laboratory. You can ask where your specimen will be sent and for their CLIA number. Go to: https://qcor.cms.gov This website will show the "certificate type" for the lab and whether the lab is functioning under a CLIA certification.

Q: Is it permissible for the testing site to ask me for payment for the test at the time of service?

A: The testing site should not ask you for payment for certain tests, but in some cases, yes. The IDPH said businesses are not allowed to charge for the test itself, but can charge a fee for administering the test. The Illinois Attorney General's office said, "Testing sites that charge a fee should be a red flag as there are many sites that provide testing with no out of pocket costs." Find out beforehand if the location plans to charge you for a rapid or PCR test. If you have insurance, the testing site may ask that information and bill your insurance. Report any issues to the Office of the Inspector General by calling 1-800-HHS-TIPS or at TIPS.HHS.GOV

Q: Are testing site allowed to ask for my personal information or protected health information before it conducts a test?

A: Yes, only contact and information related to health matters used as screening tools before doing the test. Any other information may violate the HIPPA act.

Q: What is the best way to find a reliable COVID-19 testing site?

A: Testing is available at 10 free State community-based testing sites, listed at www.dph.illinois.gov. You can reach out to a primary health care provider, nearest urgent care center, local pharmacy, and local health department for testing options.

Q: What if I never receive my test results?

A: Regardless of symptoms, follow the (CDC) guidance on isolation, quarantine, and masking at www.cdc.gov. While you are at the facility, make sure you get contact information in the event you don't hear anything within the time that is promised.

If you feel you were a victim of fraud, not charged at the time of service, but later receive a bill for testing, or if you experienced price gouging, go to https://ccformsubmission.ilag.gov/

You can contact the Village if you feel the facility is not a legitimate business. We require a license to operate in the Village Third Lake.
