While 2020 was a very unique year and caused many issues, the Village of Third Lake would like to toot its horn about the things we were able to accomplish, despite the shutdowns that occurred in our state.

We started 2020 with one of the most expensive storm water projects in Village history. We added 788 feet of large capacity storm sewers and removed 285 feet of inadequate drainage pipe without destroying many homeowner's manicured back yards. This resulted in having to rebuild and repave Windjammer Ln. with over 200 tons of asphalt.

Local vermin had created a flooding issue between retention ponds, so the Village had the line cleared and a new grate installed to limit the amount of large debris that could enter the pipe. We also installed an overflow port to make sure that the pond will not cause flooding to nearby homes. We were able to get this accomplished by working with the Mariner's Cove Homeowners Association. While working in the area, we replaced the street storm drains as a preventive measure.

As part of the Village's 5-year plan, we resurfaced over 1300 feet of roadway using over 445 tons of asphalt and replacing over 900 feet of curbs and sidewalks. In keeping with the storm water issues, we worked with several plumbing contractors and cleared numerous backyard drainage lines and street stormwater lines to improve water flow out of our streets and yards.

At the Village Hall, we added staff to help modernize the Village's operations and have placed more information on our website to make things available through digital means. We finally started accepting credit cards and increased a source of sales tax by adding businesses into the Village corporate limit. We have also created a revenue "give-back" program from the gaming machines within the Village. The Village Board of Trustees are modernizing some of our older ordinances as well.

The warm weather in 2020 caused some additional health concerns with algae blooms. Because of this, we have started a more regularly scheduled sampling and testing of the lakes to ensure they are safe to enjoy. We have also amended our Boating Ordinance to allow for an additional flag color. This will help convey important time sensitive information to our residents, such as toxic algae blooms, as we're still working on getting everyone's email address.

We will continue to work with outside agencies to improve our lakes. Clarke Environmental came out and treated the lakes for invasive species of vegetation, worked with the Zebra Mussel Hunter to start studying the zebra mussels and had Illinois Department of Natural Resources conduct a fish study for both Druce and Third Lakes.

During the shutdown, our staff made numerous deliveries of boat stickers, permits, leaf stickers, and other services requested so people could stay safe in their homes.

We have more areas of stormwater improvements to accomplish in 2021 and we will be updating some office equipment, emergency operation and codifying our ordinances. While 2020 was a great year for projects we still have more work to keep improving services for you.

Ice and Snow, Take it Slow

Snow Removal & Plow Damage

Let it snow, let it snow, let it snooooow!

As much as we love the beauty of fresh fallen snow it needs to be removed to a proper place to conduct daily activities.

With that please keep in mind that on occasion snow plow trucks may unintentionally hit a mailbox or scrape a section of sod near the curb. If this happens, please report the incident to the Village by submitting a photograph of the damage to

thirdlake@comcast.net . Leave your name, street address and a contact method to facilitate follow-up action. Avon Township will provide a temporary mailbox till spring.

Calling in a vehicle left on the road overnight during / after a snowfall of one inch or more will not excuse you from receiving a violation and parking tickets so please park in your driveway.

As a courtesy to your neighbors, please remember to shovel your sidewalks, around fire hydrants and your mailboxes to keep us all

Village Ordinance No. 11-08-05 states that there is no parking of any vehicle on Village streets at any time within 12 hours after a snowfall of one inche or more that has occurred.

Village Ordinance No. 10-06-02 states that it is unlawful to interfere with, obstruct or tend to obstruct or render dangerous for passage any street.



These ordinances will be enforced and will result, in the issuance of a \$25.00 fine.

Keeping **Pets Safe During Wintry Weather**



Not only can winter be a time of illness and injury if people fail to take appropriate health and safety precautions, but harsh winter weather conditions can be tough on pets as well.

Salt and other chemicals used to melt snow and ice can irritate the pads of your pet's feet. Wipe the feet with a damp towel before your pet licks them and irritates its mouth. Trim excess fur from your pet's pads so that ice and snow do not accumulate between its toes which can cause discomfort.

Antifreeze is a deadly poison with a sweet taste, which may attract animals. Wipe up spills and store antifreeze out of reach. If possible, use antifreeze coolant made with propylene glycol. If this is swallowed in small amounts, it will not hurt

Do not allow your dog to run freely on open ice. It can be difficult to judge the safety of the ice, and your dog could be at risk of falling through.

During the winter, it is best to keep your pets inside with the family. The happiest dogs are those that are taken out frequently for walks and exercise, but are kept inside the rest of the time. Dogs and cats crave human companionship and should be indoors with you and your family.
