## It's Time! Renew Boat Registrations and Buy Boat Stickers!

Hours: M-F, 8:30.am.-2:30 pm

### Water Craft Sticker Fees:

- ★ Sailboat/ Catamaran \$10
- ★ Electric Motors \$15
- ★ Gas Motorized Craft 10hp or less \$25
- ★ Gas Motorized Craft 11-25hp \$35
- ★ Gas Motorized Craft over 25hp \$45
- ★ Temporary Permit \$55
- ★ Transfer Fee for Temp Permit \$10
- ★ Village Launch Key \$10



Boat stickers can be purchased at the Village Hall during office hours or by phone using a credit card.

Phone # 847-223-8422. There is a form on the Village website, [www.thirdlakevillage.com](http://www.thirdlakevillage.com), please complete with boat information. A copy of your state boat registration is required. The form can be emailed to the village, [info@thirdlakevillage.com](mailto:info@thirdlakevillage.com) or stop in the Village Hall.

The Lake County Sherriff's Dept. will be monitoring the lake for state and village non compliance. Violation fines can range from \$50 to \$750.

### Why does Third Lake require boat stickers?

It offsets the cost of lake maintenance including maintenance of the dam, maintenance and electricity of the aerators in Third Lake, water sampling and safety testing, conducting fish studies and stocking the lakes with fish, oxygen monitoring, monitoring nutrient loads, conducting algae testing, vegetation studies and determining treatment when necessary. Boat stickers also allow the Village to regulate who is using the lake and limit use to registered boaters. It gives the Village a chance to reinforce boat safety and verify that boats are properly registered with the State of Illinois. The lakes are one of our greatest assets. Our community and the Village strives to keep the lakes healthy, safe and enjoyable for everyone.

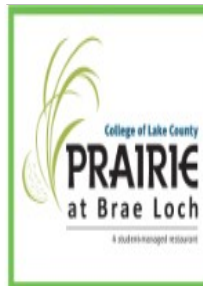
