On Monday, May 17th the Village of Third Lake received a shipment of Walleye from Keystone Hatcheries LLC, in Richmond, IL. Keystone Hatcheries LLC specializes in complete fish stocking services in Illinois and Wisconsin. They raise many species of fish at the hatchery from eggs and transport them in special fish trucks.

The official ceremony commenced at 10AM as Mayor Buckley welcomed in each new resident with the ordinances and rules of Third Lake at the boat launch off of Lake Ave. and Druce Lake beach launch in Mariner's Cove. All the new Walleye were eager to become part of their new community and swam off in exploration of their new home. Now if we could only get them to pay some property taxes that would be ideal!

We love our new residents so please remember that according to Ordinance 21-01-01, all fishermen need to practice "catch and release" of game fish from April 1<sup>st</sup> to June 15<sup>th</sup> of each year. Game fish are defined as small and large mouth bass, northern pike and walleye.


### **SWALCO 2021 Garden Learning Series**


The University of Illinois Extension, Lake County and SWALCO (Solid Waste Agency of Lake County) are happy to present the 2021 Garden Learning Series No 5.

Programs will be held on the second Wednesday of the month, 6:00 p.m. -7:30 p.m. The third in the series will be held on **June 9** (virtually) and will feature tips on garden maintenance.

These workshops are offered through a collaboration between SWALCO and University of Illinois Extension as part of a grant from USDA, focusing on local efforts to promote composting and food waste diversion. The grant also hopes to increase the generation and use of compost in commercial, residential, agriculture, and community gardens sectors in Lake County, Illinois. ### **It's Tick Season**





- Walk in the center of trails. Avoid wooded, bushy areas with high grass and leaf litter.
- Wear light-colored clothing to make ticks easier to find.
- Tuck long pants into socks and boots.
- Apply insect repellent containing 20% DEET, picaridin, IR3535, or Oil of Lemon Eucalyptus.
- Conduct a tick check on family members (underarms, ears, belly button, behind knees, between legs, waist, hair and scalp) every two to three hours. Also, check any gear or pets taken on outings.
- Put your clothes in the dryer on high for 10 minutes (or one hour for damp clothes) to kill ticks.
- Bathe or shower within two hours after coming indoors.
- If you find a tick on yourself, it is often helpful to keep the tick for species identification. Place the tick in rubbing alcohol or in a sealed bag/container to bring to your Dr.

### **June is Bicycle Safety** Month

Illinois Secretary of State Jesse White encourages children to practice safe bike riding and to remember to follow the Bicycle Rules of the Road as June marks Bicycle Safety Month. White also reminded motorists to be aware of sharing the roads with bicyclists, especially children. "As summer approaches I encourage families to enjoy riding their bicycles safely when sharing the road with vehicles," said White. "Although bike riding is fun, it can also be dangerous. It is important to wear helmets properly, obey traffic signs and signals, and supervise children as they ride bikes. By following the Bicycle Rules of the Road which include safety guidelines for bike riding, we hope that bicyclists have a safe and enjoyable ride this summer."

- Head injuries are the most serious type of injury and most common cause of death for bicyclists. Bicycle helmets have been proven to reduce the risk of head and brain injury when a crash occurs by as much as 85%.
- In 2020, 28 cyclists were killed in Illinois, according to the Illinois Department of Transportation (IDOT).
- In 2019, of the 846 cyclists killed nationwide, children under 14 years old accounted for 5% of bicyclist fatalities, according to the most updated information from the National Highway Traffic Safety Administration (NHTSA).
- In 2019, according to the Insurance Institute for Highway Safety, 78% of bicycle deaths occurred in urban areas, and 33% of bicycle deaths occurred in June, July and August.

White reminds Illinoisans that his office issues the Bicycle Rules of the Road to ensure safe bike travel. To download a copy of the Bicycle Rules of the Road, visit www.cyberdriveillinois.com.

### **Federal REAL ID Deadline Extended to May 3, 2023**

The U.S. Department of Homeland Security (DHS) has extended the federal REAL ID deadline to May 3, 2023. Current Illinois driver's licenses and ID cards will continue to be accepted at airports until May 3, 2023. White has also extended all driver's license and ID card expiration dates until Aug 1, 2021. This extension does not apply to commercial driver's licenses (CDL) and CDL learner's permits. Many transactions such as purchasing license plate stickers, obtaining duplicate driver's licenses or ID cards, and renewing standard driver's licenses or ID cards for those eligible go to www.cyberdriveillinois.com


Village boat stickers are available at the Village Hall and should be applied to your boat before putting it in the water. Without the appropriate stickers will be in violation of Boating Ordinance (21-01-01)

Seeing algae/pollen scum on the lake? Lake County Health Department tested the water and determined it is filamentous algae, pollen and also some blue-green algae. The blue-green is not releasing dangerous levels of toxins. The Village will continue to monitor this. LCHD says, 'WHEN IN DOUBT STAY OUT." Blooms can change over time so limit exposure, especially pets and children who are more prone to ingesting water.



### **OVERNIGHT PARKING**

There is no parking on Village streets between the hours of 2:00am and 7:00am. Doing so will in violation of Ordinance 11-08-05 and you will be ticketed by a Lake County Sherriff.
