# Committee of The Whole Meeting Village of Third Lake Board July 1, 2024 Minutes

4. Visitor's Comments

Bill Saemann asked the board about the possible new zoning changes regarding placement of trailers, RVs and campers. Mayor Buckley stated that village is currently updating the zoning ordinance. He explained that the current ordinance states that a resident can have two trailers and is not clear about the location. The P & Z committee is currently working to clarify not change requirements and enforce for all residents.

Bill Saemann stated that some residents are cutting seaweed and not removing from the lake. He said that this seaweed is floating towards his house.

#### **LAKES**

- Mayor Buckley stated that the red flags were raised for two days because of high water from recent storms.
- Mayor Buckley said that the new drains in Sunshine Subdivision worked well during the storms. He said that there were a few spots in Mariner's Cove that flooded, but drained fairly quickly and the sewers were not blocked.
- Mayor Buckley stated that the Mariner's Cove beach was shut down for 3 days due to E.Coli. The Lake County Health Department tested the beach after a rain and the levels were high. The beach is tested monthly during the summer.

- He said that Wisconsin Lake and Management is still waiting for the Illinois EPA permit to treat invasive species.
- Mayor Buckley stated that the Venetian Boat parade is August 3. The theme is red, white and blue.
- Mayor Buckley says that he has been busy following up on boat registrations.
- Mayor Buckley stated that the Lake County Marine unit has picked up a key to our launch and has stated that they will come out this year. He said they will contact the village with a schedule when they are available.

#### FINANCE AND POLICY

- Risk Assessment Analysis Clerk Smith stated that the auditors asked for our current risk assessment. She stated that not much has changed since the year before.
- Credit Card Policy/Spending Policy Mayor Buckley stated that the treasurer noticed that we should have a credit card spending policy since our check writing policy does not address the use of credit cards. Clerk Smith will send samples/suggestions to trustees for further discussion.

The bath will run from Almond to 45 on the north side of Washington, will cross on the north side of Washington towards CVS, then cross Washington to Marathon and connect to the current bike path at Mainsail. Additionally they will place a sidewalk between Mainsail and Sextant. He explained that the village will be responsible for maintenance of the sidewalk. Will move to consent agenda

- Village Hall brick pavers President Buckley stated the brick pavers were installed. He explained that this project was discussed 2 years ago and put an extra \$5000 in grounds budget. Since the road project was delayed, the project never started. The amount was in the budget for the current year, but needs a formal vote. The trustees agreed to move to consent agenda.
