**WAIVER AND RELEASE
OF LIABILITY**

BY SIGNING THIS FORM, IN CONSIDERATION OF GRANTING A PERMIT TO OPERATE A NON-HIGHWAY VEHICLE ON PUBLIC STREETS WITHIN THE VILLAGE OF THIRD LAKE, ILLINOIS, YOU HEREBY AGREE TO WAIVE ALL CLAIMS AND RELEASE THE VILLAGE OF THIRD LAKE, ITS OFFICERS, AGENTS, EMPLOYEES AND ALL OTHER PERSONS FROM ANY AND ALL LIABILITY FOR ANY INJURIES, LOSSES, DAMAGES, COSTS AND EXPENSES YOU MAY INCUR THROUGH YOUR OPERATION OF A NON-HIGHWAY VEHICLE ON PUBLIC STREETS WITHIN THE VILLAGE OF THIRD LAKE. YOU FURTHER HEREBY REPRESENT THAT YOU ARE 18 YEARS OF AGE OR OLDER.

This Release and Waiver of Liability (the "Release") executed on this ____ day of _____, 20__, by _____ (the "Applicant") in favor of the Village of Third Lake, its officers, elected and appointed officials, employees and agents (collectively "Village").

Applicant desires to obtain a permit to operate a Non-Highway Vehicle in the Village of Third Lake (the "Permitted Activity").

Applicant hereby freely, voluntarily, and without duress executes this Release and agrees to the following terms:

Release and Waiver: Applicant does hereby release, indemnify and hold harmless Village and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Applicant's participation in the Permitted Activity.

Applicant understands that this Release discharges Village from any liability or claim that the Applicant may have against Village with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Applicant's participation in the Permitted Activity, whether caused by the negligence of Village or its officers, appointed or elected officials, employees, or agents or otherwise. Applicant also understands that Village does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment: Applicant does hereby release and forever discharge Village from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Applicant's participation in the Permitted Activity.

Assumption of the Risk: Applicant understands that the Permitted Activity may in certain circumstances include a risk of injury to the Applicant. Applicant hereby expressly and specifically assumes the risk of injury or harm in the Permitted Activity and releases Village from all liability for injury, illness, death, or property damage resulting from the participation in the Permitted Activity.
